UNPUBLISHED DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

Pursuant to 42 U.S.C. § 300aa-15(e), petitioner has requested a total of \$204,379.00 in attorneys' fees and costs. The undersigned tentatively found that petitioner requested a reasonable amount and was entitled to the full amount requested. The undersigned allowed respondent an opportunity to comment. Respondent did not interpose any objections within the time permitted.

Petitioner's attorney, attorney staff, and expert have requested hourly rates that are consistent with the rates previously awarded. The number of hours is reasonable. Thus, the amount requested is reasonable.

Petitioner is awarded \$204,379.00. This amount shall be made payable in two forms: first, the amount of \$127,239.50 as a lump sum in the form of a check

jointly payable to petitioner and petitioner's counsel, Renee Gentry, for work at the Vaccine Injury Litigation Clinic at The George Washington University Law School, and second, the amount of \$77,139.50 as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, Renee Gentry, for work at the The Law Office of Renee Gentry.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
