DECISION¹

On September 20, 2011, Lauren Farb (“Petitioner”) filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to -34 (2006). Petitioner alleged that a tetanus-diphtheria-acellular-pertussis (“Tdap”) vaccine administered on April 15, 2009 caused her to suffer from chronic anaphylaxis. On October 29, 2014, the undersigned issued a decision awarding compensation to Petitioner.

On March 17, 2015, Petitioner filed an Application for Attorneys’ Fees and Costs. Petitioner requests reimbursement for total fees and costs in the amount of \$67,405.33. Petitioner represents that, of this amount, she personally incurred \$447.80 in costs. *See* General Order Number 9 Statement, filed March 17, 2015, at 1.

As provided by Vaccine Rule 18(b), each party has 14 days within which to request redaction “of any information furnished by that party: (1) that is a trade secret or commercial or financial in substance and is privileged or confidential; or (2) that includes medical files or similar files, the disclosure of which would constitute a clearly unwarranted invasion of privacy.” Vaccine Rule 18(b).

² The National Vaccine Injury Compensation Program is set forth in Part 2 of the National Childhood Vaccine Injury Act of 1986, Pub. L. No. 99-660, 100 Stat. 3755, codified as amended, 42 U.S.C. §§ 300aa-1 to -34 (2006) (Vaccine Act or the Act). All citations in this decision to individual sections of the Vaccine Act are to 42 U.S.C.A. § 300aa.

On March 27, 2015, the parties informally notified the undersigned's chambers that Respondent has no objection to the requested fees and costs.

The undersigned finds that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. § 300aa-15(b) and (e)(1). Further, the proposed amounts seem reasonable and appropriate. **Accordingly, the undersigned hereby awards the amount of \$66,957.53, in the form of a check made payable jointly to Petitioner and Petitioner's counsel, Ronald Homer, of the law firm of Conway, Homer & Chin-Caplan, P.C.; and \$447.80, in the form of a check made payable solely to Petitioner.**

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
