### **DECISION AWARDING ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On April 22, 2015, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

Petitioners submitted their request for attorneys' fees and costs to respondent, requesting reimbursement for attorneys' fees and costs in the amount of \$26,472.30, consisting of \$26,072.30

When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

in attorneys' fees and costs and \$400.00 in petitioners' costs. Respondent does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the court awards:

- a. **\$26,072.30**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioners and Creech Law Firm, P.A. in the amount of **\$26,072.30**; and
- b. **\$400.00**, representing reimbursement for petitioners' costs. The award shall be in the form of a check payable to petitioners in the amount of **\$400.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.<sup>2</sup>

**IT IS SO ORDERED.**
