DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 19, 2014, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

In accordance with the General Order #9 requirement, petitioner asserts that he did not incur any costs in pursuit of his petition. Petitioner submitted his request for attorneys' fees and costs to respondent. Petitioner requests \$32,233.05 in reimbursement for attorneys' fees and costs, consisting of \$20,114.00 in attorneys' fees and \$12,119.05 in attorneys' costs. Respondent

does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the court awards **\$32,233.05**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and the Law Offices of Jack D. Miller, in the amount of **\$32,233.05**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
