### **DECISION AWARDING INTERIM ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On May 1, 2015, the parties filed a stipulation of fact in which they agreed on an appropriate amount for interim attorneys' fees and costs in this case.

Petitioner filed an application for interim attorneys' fees and costs on April 17, 2015. During informal discussions, respondent raised objections to certain items in petitioner's application. Based on these objections, petitioner amends her application for interim attorneys'

When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

fees and costs to request \$24,042.81, consisting of \$23,750.00 in attorneys' fees and costs and \$292.81 in petitioner's costs. This amount covers all attorneys' fees and litigation costs for the period of representation through April 30, 2015. Respondent does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the court awards:

- a. **\$23,750.00**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and Conway, Homer & Chin-Caplan, P.C., in the amount of **\$23,750.00**; and
- b. **\$292.81**, representing reimbursement for petitioner's costs. The award shall be in the form of a check payable to petitioner in the amount of **\$292.81**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.<sup>2</sup>
