DECISION ON ATTORNEY FEES AND COSTS¹

Gowen, Special Master:

In this case under the National Vaccine Injury Compensation Program,² I issued a Decision on April 8, 2015, adopting the parties' stipulation for award. Additionally, on April 8, 2015, the parties filed a Stipulation of Fact concerning attorneys' fees and costs. Pursuant to General Order #9, the parties represented that petitioner has not personally incurred any litigation costs in this matter.

The parties' stipulation indicates that respondent does not object to the amended amount of \$14,257.50 that petitioner is requesting for attorneys' fees and \$2,626.34 in attorneys' cost, for a total amount of \$16,883.84.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems

reasonable and appropriate. **Accordingly, I hereby award:**

- **a lump sum of \$16,883.84 in the form of a check payable jointly to petitioner and petitioner's attorney, Edward Kraus, Esq., for petitioner's attorneys' fees and costs.**

The clerk of the court shall enter judgment in accordance herewith.³

IT IS SO ORDERED.
