DECISION ON ATTORNEY FEES AND COSTS¹

Vowell, Special Master:

On July 18, 2014, Imrana Mumtaz (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² [the “Vaccine Act” or “Program”]. Petitioner alleged that, as a result of receiving an influenza vaccine on October 1, 2013, she suffered a shoulder injury the residual effects of which lasted more than six months. (See Stipulation for Award, filed December 30, 2014, ¶¶ 1-4 (ECF No. 17).) On December 31, 2014, I issued a decision awarding compensation to petitioner based on the parties’ stipulation.

On January 5, 2015, the parties filed a Stipulation of Fact Concerning Attorneys' Fees and Costs. (ECF No. 19.) According to the stipulation, the parties agree upon a total award of attorneys' fees and costs to petitioner in the amount of \$14,500.00. (*Id.*) In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses. (*Id.*)

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300aa-15(e). I find the proposed amount to be reasonable.

Accordingly, I award the total \$14,500.00³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Maximillian J. Muller.

The clerk of the court shall enter judgment in accordance herewith.⁴

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See *generally Beck v. Sec'y HHS*, 924 F.2d 1029 (Fed. Cir.1991).

⁴ Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by each filing a notice renouncing the right to seek review by a United States Court of Federal Claims judge.
