DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On November 13, 2014, petitioner filed a petition under the National Childhood Vaccine Injury Act, 42 U.S.C. §§ 300aa-10–34 (2012) (“Vaccine Act”) alleging she suffered injuries including panuveitis, uveitis, and vasculitis as a result of her receipt of the diphtheria-tetanus-acellular pertussis (“Tdap”) vaccine on January 20, 2012. On March 4, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties’ stipulation.

On August 29, 2016, petitioner filed a motion for attorneys’ fees and costs. Petitioner

When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document’s disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

requests a total award of \$22,813.97 in attorneys' fees and costs. In compliance with General Order #9, petitioner states she incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and the lack of opposition, the undersigned **GRANTS** petitioner's application for attorneys' fees and costs.

Accordingly, the undersigned awards the total amount of \$22,813.97, as a lump sum in the form of a check payable jointly to petitioner and Ward Black Law.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

IT IS SO ORDERED.
