DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On March 23, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² [the "Vaccine Act"]. Petitioner alleged that as a result of an Influenza ("flu") vaccination on September 13, 2013, she suffered a shoulder injury related to vaccine administration ("SIRVA"). On December 3, 2015, the undersigned issued a decision awarding compensation to petitioner based on respondent's proffer.

On January 19, 2016, petitioner filed a motion for attorneys' fees and costs. On February 1, 2016, the parties filed a Stipulation of Fact Concerning Attorneys' Fees and Costs. According to the stipulation, the parties stipulate to an award of \$30,412.75 in attorneys' fees and \$1,093.86 in costs. In accordance with General Order #9, petitioner

represents that she is entitled to reimbursement of \$56.49 payable directly to her for costs incurred in this matter.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and the lack of any objection by respondent, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs, and payment of petitioner's own costs.

The undersigned awards the total of \$56.49 as a lump sum in the form of a check payable to petitioner for her own costs incurred in this matter.

The undersigned awards the total of \$31,506.61³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Renee Gentry for attorneys' fees and costs.

The clerk of the court shall enter judgment in accordance herewith.⁴

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See generally *Beck v.
