DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On October 7, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a left shoulder injury caused by her September 12, 2014 influenza vaccination. Petition, at ¶¶ 2-3, 8. On March 29, 2016, the undersigned issued a decision awarding compensation to petitioner based on respondent's Proffer. (ECF No. 19).

On June 8, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 25).³ Petitioner requests attorneys' fees and costs in the amount of \$15,509.71. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$15,509.71⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, Amber D. Wilson, Esq.

The clerk of the court shall enter judgment in accordance herewith.⁵

³ In the motion, petitioner states that respondent has no objections to petitioner's motion.

⁴ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. *See generally Beck v. Sec'y of Health & Human Servs.*, 924 F.2d 1029 (Fed. Cir.1991).

⁵ Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by the parties' joint filing of notice renouncing the right to seek review.
