DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On January 7, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered Guillain-Barré Syndrome ("GBS") after receiving the influenza vaccine on October 16, 2014. Petition at 1. On October 13, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation. (ECF No. 23).

On November 4, 2016, petitioner filed a motion for attorneys' fees and costs. (ECF No. 28). Petitioner requests attorneys' fees in the amount of \$18,166.50 and attorneys' costs in the amount of \$842.13 for a total amount of \$19,008.63. *Id.* at 1. In compliance with General Order #9, petitioner has filed a signed statement indicating

petitioner incurred no out-of-pocket expenses. See Petitioner's General Order #9 Statement, filed as 4th Attachment to Petitioner's Motion for Attorneys' Fees and Costs (ECF No. 28).

On November 21, 2016, respondent filed a response stating respondent has no objection to the overall amount sought by petitioner. (ECF No. 29).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$19,008.63³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Jeffrey S. Pop.

The clerk of the court shall enter judgment in accordance herewith.⁴

IT IS SO ORDERED.

³ This amount is intended to cover all legal expenses incurred in this matter.
