RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On March 31, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that she experienced severe left shoulder pain caused-in-fact by her November 4, 2014 influenza vaccination. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On August 26, 2016, respondent filed her Rule 4(c) report in which she concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent "has concluded that compensation is appropriate. Petitioner's injury is consistent with shoulder injury related to vaccine administration (SIRVA), and it was caused in fact by the flu vaccination administered on November 4, 2014." *Id.* at 3. Respondent further agrees that no other cause for petitioner's SIRVA

has been identified, that petitioner has suffered the sequela of her injury for more than six months, and that petitioner has satisfied all legal prerequisites for compensation under the Vaccine Act. *Id.*

In view of respondent's concession and the evidence before me, the undersigned finds that petitioner is entitled to compensation.
