DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On June 22, 2016, Keven Otteni (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that he suffered a shoulder injury related to vaccine administration (“SIRVA”) as a result of an influenza (“flu”) vaccine that was administered to his left shoulder on October 25, 2015. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On November 3, 2016, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On April 26, 2017, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$172,374.91. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the

proffered award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$172,374.91, in the form of a check payable to petitioner, Kevin Otteni.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³
