DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On June 23, 2016, Audrey Cropp (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleged that she sustained right shoulder injuries from an influenza (“flu”) vaccination she received on September 1, 2015. The case was assigned to the Special Processing Unit (“SPU”) of the Office of Special Masters.

On November 29, 2016, the undersigned issued a ruling on entitlement finding petitioner entitled to compensation for a shoulder injury related to vaccine administration (“SIRVA”). On December 22, 2016, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$75,531.50. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$75,531.50 in the form of a check payable to petitioner, Audrey Cropp.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³
