DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On August 3, 2016, Susan Cobbina ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a right shoulder injury, including shoulder bursitis, as a result of receiving an influenza ("flu") vaccine on December 5, 2015. On December 12, 2016, the undersigned issued a decision awarding compensation to petitioner based on respondent's proffer. (ECF No. 19).

On April 6, 2017, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 24).³ Petitioner requests attorneys' fees in the amount of \$9,996.90,

and attorneys' costs in the amount of \$687.35, for a total amount of \$10,684.25. *Id.* at 1-2. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$10,684.25,⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel F. John Caldwell, Jr.⁵

The clerk of the court shall enter judgment in accordance herewith.⁶
