### **DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>**

**Dorsey**, Chief Special Master:

On August 5, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that that she suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of her September 30, 2015 influenza ("flu") vaccination. On April 14, 2017, the undersigned issued a decision awarding compensation to petitioner based on the parties' Stipulation. (ECF No. 22).

On April 24, 2017, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 25).<sup>3</sup> Petitioner requests attorneys' fees in the amount of \$7,075.00

<sup>3</sup> In the motion, petitioner states that respondent "does not object to the overall amount sought, as it is not a unreasonable amount to have been incurred for proceedings in this case to date. Respondent's lack of

and attorneys' costs in the amount of \$1,370.18 for a total amount of \$8,445.18. *Id.* at 1-3. In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses. (ECF No. 25-1 at 4).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

**Accordingly, the undersigned awards the total of \$8,445.18<sup>4</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, Stephen I. Leshner.**

The clerk of the court shall enter judgment in accordance herewith.<sup>5</sup>

<sup>4</sup> This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See *generally Beck v. Sec'y of Health & Human Servs.*, 924 F.2d 1029 (Fed. Cir.1991).

<sup>5</sup> Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by the parties' joint filing of notice renouncing the right to seek review.
