RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On October 25, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that that Ms. Gibbins suffered Guillain-Barré Syndrome (“GBS”) as a result of an influenza (“flu”) vaccine administered on October 24, 2013. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 18, 2017, respondent filed his Rule 4(c) report in which he states that he does not contest that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent states that "Ms. Gibbins has satisfied the criteria set forth in the newly revised Vaccine Injury Table ("Table")." *Id.* at 5. Respondent further acknowledges that "petitioner may re-file this petition and be afforded a presumption of causation under the revised Table (see 42 U.S.C. § 300aa-16(b))." *Id.* In light of this, respondent states that he will not contest entitlement to compensation in this case. *Id.*

In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.
