DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On November 21, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that she suffered a right shoulder injury caused in fact by the influenza vaccination she received on October 8, 2015. Petition at 1, ¶¶ 2, 11. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 14, 2018, the undersigned issued a ruling on entitlement, finding petitioner entitled to compensation for her shoulder injury. On September 3, 2019, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$115,906.59. Proffer at 1. In the Proffer, respondent represented

that petitioner agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$115,906.59 in the form of a check payable to petitioner, Monica Portee.** This amount represents compensation for all damages that would be available under § 15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³

RESPONDENT’S PROFFER ON AWARD OF COMPENSATION

On September 14, 2018, the Court entered its Ruling on Entitlement, finding petitioner, Monica Portee, entitled to Vaccine Act compensation. Respondent herein proffers the following amount(s) of reasonable compensation due petitioner.

I. Items of Compensation

Based upon the evidence of record, respondent proffers that petitioner should be awarded a lump sum total of \$115,906.59, which amount represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a).¹ Petitioner agrees.

¹ Should petitioner die prior to entry of judgment, the parties reserve the right to move the Court for appropriate relief. In particular, respondent would oppose any award for future medical expenses and future pain and suffering.

II. Form of the Award

The parties recommend that the compensation provided to petitioner should be made through a lump sum payment of \$115,906.59 in the form of a check payable to petitioner, Monica Portee.² Petitioner agrees.
