DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On November 22, 2016, Ron W. Flood (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that he suffered a right shoulder injury related to vaccine administration (“SIRVA”) as a result of his October 16, 2014 influenza (“flu”) vaccination. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On July 14, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On August 7, 2017, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$125,000.00. Proffer at 1-2. In the Proffer, respondent represented that petitioner agrees with the proffered

award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$125,000.00, in the form of a check payable to petitioner, Ron W. Flood.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³

IT IS SO ORDERED.

RESPONDENT’S PROFFER ON AWARD OF COMPENSATION

On November 22, 2016, Ron W. Flood (“petitioner”) filed a petition for vaccine injury compensation alleging that he suffered a right shoulder injury related to vaccine administration (“SIRVA”), which was caused-in-fact by an influenza (“flu”) vaccination administered on October 16, 2014. Respondent filed his Rule 4(c) Report conceding entitlement to compensation on July 13, 2017. The Chief Special Master issued a Ruling on Entitlement on July 14, 2017.

I. Items of Compensation

Based upon the evidence of record, respondent proffers that petitioner should be awarded \$125,000.00, which represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a).¹ Petitioner agrees.

¹ Should petitioner die prior to entry of judgment, the parties reserve the right to move the Court for appropriate relief. In particular, respondent would oppose any award for future medical expenses, future lost earnings, and future pain and suffering.

II. Form of the Award

The parties recommend that the compensation provided to petitioner should be made through a lump sum payment of \$125,000.00 in the form of a check payable to petitioner.²

Petitioner agrees.
