### **RULING ON ENTITLEMENT**<sup>1</sup>

**Dorsey**, Chief Special Master:

On January 18, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that that she suffered a left shoulder injury that was caused-in-fact by the influenza (“flu”) vaccine she received on December 8, 2015. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 1, 2017, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent states that “petitioner’s alleged injury is consistent with SIRVA and that it was caused-in-fact by the flu vaccine she received on

December 8, 2015.” *Id.* at 4. Respondent further agrees that the statutory six month sequela requirement has been satisfied. *Id.*

**In view of respondent’s position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.**
