RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On February 6, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that “petitioner suffered “left shoulder injuries” that were “caused in fact” by an influenza (“flu”) vaccine petitioner received on October 15, 2015.” Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On May 29, 2019, respondent filed his Rule 4(c) report in which he states that he does not contest that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent “based on the record as it now stands

and subject to his right to appeal the Ruling of Facts, respondent does not dispute that petitioner has satisfied all legal prerequisites for compensation under the Act.” *Id.* at 5.

In view of respondent’s position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.
