DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On February 15, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he received an influenza vaccine on October 2, 2015, and thereafter suffered from a shoulder injury which was caused-in-fact by the flu vaccine. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 26, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for a shoulder injury related to vaccine administration (“SIRVA”). Respondent included a Proffer on Award of Compensation (“Proffer”) in his Rule 4(c) Report filed on September 22, 2017, indicating petitioner should be awarded \$90,600.00. In the Proffer, respondent represented that petitioner agrees with the proffered award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the Proffer, **the undersigned awards petitioner a lump sum payment of \$90,600.00 in the form of a check payable to petitioner, Ralph Lagamma.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³
