RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On July 27, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that he suffered a shoulder injury related to vaccine administration (“SIRVA”) as a result of an influenza (“flu”) vaccination administered on October 19, 2016. Petition at 1, 10. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 9, 2018, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent concluded that while petitioner does not qualify as suffering a Table SIRVA, his petitioner’s alleged injury was caused-in-fact by the flu vaccine. *Id.* at

7-8. Respondent further agrees that petitioner has met the statutory requirements for entitlement to compensation. *Id.*

In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.
