DECISION ON ATTORNEYS' FEES AND COSTS¹

On December 21, 2022, Jayden Sumrall ("Petitioner") filed a motion for attorneys' fees and costs. Motion for Attorney Fees and Costs ("Fees App.") (ECF No. 84). For the reasons discussed below, I **GRANT** Petitioner's motion for attorneys' fees and costs and award a total of **\$13,067.60**.

I. Procedural History

On November 13, 2017, Petitioner filed a petition in the National Vaccine Injury Compensation Program.² Petitioner alleged that he suffered from postural orthostatic tachycardia syndrome, arthritis, and reoccurring headaches as a result of receiving human papillomavirus vaccinations on December 3, 2013, November 18, 2014, and January 20, 2016. *See* Petition (ECF

No. 1). On December 7, 2022, Petitioner filed an unopposed motion for a decision dismissing his petition and on December 8, 2022, I issued my decision dismissing the petition for insufficient proof. (ECF No. 84).

On December 21, 2022, Petitioner filed a motion for final attorneys' fees and costs. Petitioner requests compensation for his attorney, Mr. Mark Sadaka, in the total amount of \$13,067.60, representing \$13,028.60 in attorneys' fees and \$39.00 in costs.³ Fees App. at 4. Pursuant to General Order No. 9, Petitioner warrants he has personally incurred costs of \$24.04 in pursuit of his claim. *Id.* at 1. Respondent did not file a response. Petitioner filed a reply on January 13, 2023, highlighting Respondent's lack of response and reiterating his belief that the requested amount for fees and costs is reasonable.

The matter is now ripe for adjudication.

II. Analysis

Section 15(e) (1) of the Vaccine Act allows for the Special Master to award "reasonable attorneys' fees, and other costs." § 300aa-15(e)(1)(A)–(B). Petitioners are entitled to an award of reasonable attorneys' fees and costs if they are entitled to compensation under the Vaccine Act, or, even if they are unsuccessful, they are eligible so long as the Special Master finds that the petition was filed in good faith and with a reasonable basis. *Avera v. Sec'y of Health & Human Servs.*, 515 F.3d 1343, 1352 (Fed. Cir. 2008). Here, I previously found that petitioner had established good faith and reasonable basis when awarding interim attorneys' fees and costs, and the work performed from that point until the end of the case was also reasonable. Accordingly, Petitioner is entitled to a final award of reasonable attorneys' fees and costs.

Petitioners "bea[r] the burden of establishing the hours expended, the rates charged, and the expenses incurred" are reasonable. *Wasson v. Sec'y of Health & Human Servs.*, 24 Cl. Ct. 482, 484 (1993). Adequate proof of the claimed fees and costs should be presented when the motion is filed. *Id.* at 484 n. 1. The special master has the discretion to reduce awards *sua sponte*, independent of enumerated objections from the respondent. *Sabella v. Sec'y of Health & Human Servs.*, 86 Fed. Cl. 201, 208–09 (Fed. Cl. 2009); *Savin v. Sec'y of Health & Human Servs.*, 85 Fed. Cl. 313 (Fed. Cl. 2008), *aff'd* No. 99–537V, 2008 WL 2066611 (Fed. Cl. Spec. Mstr. Apr. 22, 2008).

a. Attorneys' Fees

Petitioner requests that his attorney, Mr. Mark Sadaka, be compensated at the following hourly rates: \$444.00 per hour for work performed in 2021 and \$458.00 per hour for work performed in 2022. These rates are consistent with what Mr. Sadaka has previously been awarded for his Vaccine Program work, and I find them to be reasonable for his work in the instant case as well.

Turning next to review of the submitted billing statement, I find that the overall hours spent on this matter to be reasonable. The entries are reasonable and accurately describe the work being

performed and the length of time it took to perform each task. Respondent also has not identified any particular entries as being objectionable. Therefore, Petitioner is entitled to final attorneys' fees of \$13,028.60.

b. Attorneys' Costs

Like attorneys' fees, a request for reimbursement of costs must be reasonable. *Perreira v. Sec'y of Health & Human Servs.*, 27 Fed. Cl. 29, 34 (Fed. Cl. 1992). Petitioner requests total attorneys' costs in the amount of \$39.00. This amount is comprised of acquiring medical records and postage. Fees App. Ex. 2. Petitioner has provided adequate documentation supporting these costs and all appear reasonable in my experience. Petitioner is therefore awarded the full amount of costs sought.

III. Conclusion

In accordance with the foregoing, Petitioner's motion for attorneys' fees and costs is **GRANTED**. I find that Petitioner is entitled to a reimbursement of attorneys' fees and costs as follows:

Accordingly, I award the following: a lump sum in the amount of \$13,067.60, representing reimbursement for Petitioner's attorneys' fees and costs, in the form of a check payable to Petitioner and his attorney, Mr. Mark Sadaka.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court shall enter judgment in accordance herewith.⁴

IT IS SO ORDERED.
