RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On July 18, 2018, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (SIRVA) in her right shoulder from an influenza (“flu”) vaccine administered on October 11, 2017. Petition at 1, 7. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On August 9, 2019, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent states that "a preponderance of the medical evidence establishes that petitioner's right shoulder post-vaccination bursitis was caused-in-fact by the flu vaccine she received on October 11, 2017." *Id.* at 7. Respondent further agrees that "petitioner has satisfied all legal prerequisites for compensation under the Vaccine Act." *Id.* at 8.

In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.

IT IS SO ORDERED.
