DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On August 27, 2018, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (“SIRVA”) as a result of an influenza (“flu”) vaccination administered on September 17, 2015. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On August 12, 2019, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On August 8, 2019, respondent filed a combined Rule 4 report/proffer on award of compensation (“Rule 4/Proffer”) indicating petitioner should

be awarded \$110,000. Rule 4/Proffer at 3. In the Rule 4/Proffer, respondent represented that petitioner agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Rule 4/Proffer.

Pursuant to the terms stated in the Rule 4/Proffer, **the undersigned awards petitioner a lump sum payment of \$110,000 in the form of a check payable to petitioner, Terri L. Vanderjack.** This amount represents compensation for all damages that would be available under § 15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³
