DECISION ON ATTORNEYS’ FEES AND COSTS¹

On October 12, 2018, E.A. (“Petitioner”) filed a petition in the National Vaccine Injury Program² alleging that she suffered Bell’s palsy as the result of an influenza (“flu”) vaccination administered on October 19, 2015. Petition at Preamble (ECF No. 1). On January 24, 2023, the undersigned issued a ruling finding Petitioner entitled to compensation. Ruling on Entitlement dated Jan. 24, 2023 (ECF No. 112). On March 14, 2024, the undersigned issued a decision based on proffer. Decision Awarding Damages Based on Proffer dated Mar. 14, 2024 (ECF No. 161).

On October 8, 2024, Petitioner filed an application for attorney's fees and costs. Petitioner's Application for Attorneys' Fees and Costs ("Pet. App."), filed Oct. 8, 2024 (ECF No. 165). Petitioner requests compensation in the amount of \$104,094.60, representing \$81,532.30 in attorney's fees and \$22,562.30 in costs. *Id.* at 1-2. Pursuant to General Order No. 9, Petitioner warrants that she has personally incurred \$28.01 in costs in pursuit of her claim for compensation. *Id.* at 2. Respondent filed his response on October 22, 2024, stating he "is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case." Respondent's Response to Pet. Mot., filed Oct. 22, 2024, at 2 (ECF No. 167). The matter is now ripe for disposition.

For the reasons discussed below, the undersigned **GRANTS** Petitioner's motion and awards a total of \$104,122.61.

I. DISCUSSION

Under the Vaccine Act, the special master shall award reasonable attorneys' fees and costs for any petition that results in an award of compensation. § 15(e)(1). When compensation is not awarded, the special master "may" award reasonable attorneys' fees and costs "if the special master or court determines that the petition was brought in good faith and there was a reasonable basis for the claim for which the petition was brought." *Id.* In this case, because Petitioner was awarded compensation pursuant to a proffer, she is entitled to a final award of reasonable attorneys' fees and costs.

A. Reasonable Attorneys' Fees

The Federal Circuit has approved use of the lodestar approach to determine reasonable attorneys' fees and costs under the Vaccine Act. *Avera v. Sec'y of Health & Hum. Servs.*, 515 F.3d 1343, 1349 (Fed. Cir. 2008). Using the lodestar approach, a court first determines "an initial estimate of a reasonable attorney's fee by 'multiplying the number of hours reasonably expended on the litigation times a reasonable hourly rate.'" *Id.* at 1347-58 (quoting *Blum v. Stenson*, 465 U.S. 886, 888 (1984)). Then, the court may make an upward or downward departure from the initial calculation of the fee award based on other specific findings. *Id.* at 1348.

Counsel must submit fee requests that include contemporaneous and specific billing records indicating the service performed, the number of hours expended on the service, and the name of the person performing the service. *See Savin v. Sec'y of Health & Hum. Servs.*, 85 Fed. Cl. 313, 316-18 (2008). Counsel should not include in their fee requests hours that are "excessive, redundant, or otherwise unnecessary." *Saxton v. Sec'y of Health & Hum. Servs.*, 3 F.3d 1517, 1521 (Fed. Cir. 1993) (quoting *Hensley v. Eckerhart*, 461 U.S. 424, 434 (1983)). It is "well within the special master's discretion to reduce the hours to a number that, in [her] experience and judgment, [is] reasonable for the work done." *Id.* at 1522. Furthermore, the special master may reduce a fee request *sua sponte*, apart from objections raised by Respondent and without providing a petitioner notice and opportunity to respond. *See Sabella v. Sec'y of Health & Hum. Servs.*, 86 Fed. Cl. 201, 209 (2009).

A special master need not engage in a line-by-line analysis of a petitioner's fee application when reducing fees. Broekelschen v. Sec'y of Health & Hum. Servs., 102 Fed. Cl. 719, 729 (2011). Special masters may rely on their experience with the Vaccine Program and its attorneys to determine the reasonable number of hours expended. Wasson v. Sec'y of Health & Hum. Servs., 24 Cl. Ct. 482, 484 (Fed. Cl. Nov. 19, 1991), rev'd on other grounds & aff'd in relevant part, 988 F.2d 131 (Fed. Cir. 1993). Just as "[t]rial courts routinely use their prior experience to reduce hourly rates and the number of hours claimed in attorney fee requests . . . [v]accine program special masters are also entitled to use their prior experience in reviewing fee applications." Saxton, 3 F.3d at 1521.

i. Reasonable Hourly Rates

Petitioner requests the following hourly rates for the work of her counsel: for Mr. Ronald Homer, \$421.00 per hour for work performed in 2018, \$430.00 per hour for work performed in 2019, \$447.00 per hour for work performed in 2020 and 2021, \$475.00 per hour for work performed in 2022, \$500.00 per hour for work performed in 2023, and \$525.00 per hour for work performed in 2024; for Mr. Patrick Kelly, \$225.00 per hour for work performed in 2020, \$250.00 per hour for work performed in 2022, and \$305.00 per hour for work performed in 2023; for Ms. Meredith Daniels, \$320.00 per hour for work performed in 2019, \$350.00 per hour for work performed in 2020 and 2021, \$410.00 per hour for work performed in 2022, \$455.00 per hour for work performed in 2023, and \$485.00 per hour for work performed in 2024; for Ms. Christina Ciampolilo, \$342.00 per hour for work performed in 2018, \$350.00 per hour for work performed in 2019, \$380.00 per hour for work performed in 2020 and 2021, \$425.00 per hour for work performed in 2022, \$470.00 per hour for work performed in 2023, and \$500.00 per hour for work performed in 2024; for Ms. Lauren Faga, \$279.00 per hour for work performed in 2018, \$330.00 per hour for work performed in 2021; and \$425.00 per hour for work performed in 2023; and for Mr. Joseph Pepper, \$355.00 per hour for work performed in 2020 and 2021, \$415.00 per hour for work performed in 2022, \$455.00 per hour for work performed in 2023, and \$485.00 per hour for work performed in 2024. Petitioner also requests rates between \$142.00 and \$195.00 for work of her counsel's paralegals and law clerks performed from 2018 to 2024.

The undersigned finds the rates are consistent with what counsel have previously been awarded for their Vaccine Program work, and finds them to be reasonable herein.

ii. Reasonable Hours Expended

In reducing an award of fees, the goal is to achieve rough justice, and therefore a special master may take into account their overall sense of a case and may use estimates when reducing an award. See Florence v. Sec'y of Health & Hum. Servs., No. 15-255V, 2016 WL 6459592, at *5 (Fed. Cl. Spec. Mstr. Oct. 6, 2016) (citing Fox v. Vice, 563 U.S. 826, 838 (2011)). It is well established that an application for fees and costs must sufficiently detail and explain the time billed so that a special master may determine, from the application and the case file, whether the amount requested is reasonable. Bell v. Sec'y of Health & Hum. Servs., 18 Cl. Ct. 751, 760 (1989); Rodriguez v. Sec'y of Health & Hum. Servs., No. 06-559V, 2009 WL 2568468 (Fed. Cl. Spec. Mstr. July 27, 2009). Petitioner bears the burden of documenting the fees and costs claimed. Rodriguez, 2009 WL 2568468 at *8.

The undersigned has reviewed the submitted billing entries and finds the total number of hours billed to be reasonable and will award them in full.

B. Attorneys' Costs

Petitioner requests a total of \$22,562.30 in attorney's costs. This amount is comprised of the filing fee, acquiring medical records, FedEx and other shipping costs, and expert costs,. The undersigned has reviewed the requested costs and finds them to be reasonable and well supported with appropriate documentation. Thus, she will award costs in full.

C. Petitioner's Costs

Petitioner requests \$28.01 in personally incurred costs. These are reasonable and well supported with documentation, and will be awarded in full.

II. CONCLUSION

Based on all of the above, the undersigned finds that it is reasonable to compensate Petitioner and her counsel as follows:

Petitioner is awarded attorneys' fees and costs in the total amount of \$104,122.61 (representing \$104,094.60 for Petitioner's attorneys' fees and costs and \$28.01 for Petitioner's personally incurred costs) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the Clerk of Court **SHALL ENTER JUDGMENT** in accordance with this decision.³
