DECISION ON ATTORNEY'S FEES AND COSTS¹

On November 8, 2018, Jennifer Wood ("Petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration as a result of a tetanus, diphtheria, acellular pertussis vaccine administered on January 23, 2017. (Petition at 1). On February 24, 2021, a decision was issued awarding compensation to Petitioner based on the Respondent's proffer. (ECF No. 48).

Petitioner has now filed a motion for attorney's fees and costs, dated June 25, 2021, (ECF No. 53), requesting a total award of \$14,167.48 (representing \$12,748.50 in fees and \$1,418.98 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that Petitioner incurred no out-of-pocket expenses. (ECF No. 52). Respondent reacted to the motion on July 13, 2021, indicating that he does not object to the amount sought as it is not an unreasonable amount to have been incurred in this case. (ECF No. 54). By email correspondence on July 13, 2021, counsel for Petitioner informed the staff attorneys office that Petitioner did not intend to file a reply. See *Informal Remark*, July 13, 2021.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). I award a total of **\$14,167.48** (representing \$12,748.50 in fees and \$1,418.98 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³
