DECISION BASED ON STIPULATION¹

On November 27, 2018, Arthur Lytle, Jr. ("petitioner") filed a petition in the National Vaccine Injury Compensation Program.² Petitioner alleged that as a result of an influenza ("flu") vaccine on October 11, 2016, he developed a shoulder injury related to vaccine administration ("SIRVA"). Petition at 1 (ECF No. 1).

On June 7, 2021, the parties filed a stipulation recommending an award of compensation to petitioner. Stipulation (ECF No. 57). Respondent denies that petitioner suffered a Table injury for SIRVA, denies that the vaccine either caused or significantly aggravated petitioner's

alleged injury or any other injury, and denies that petitioner's current disabilities are the result of a vaccine-related injury. Id. at ¶ 6. Nevertheless, the parties agree to the joint stipulation, attached hereto as Appendix A. The undersigned finds the stipulation reasonable and adopts it as the decision of the Court in awarding damages, on the terms set forth therein.

The parties stipulate that petitioner shall receive the following compensation:

- (1) **A lump sum of \$45,000.00 in the form of a check payable to petitioner.**
- (2) **A lump sum of \$183.12 for payment of a State of Michigan Medicaid lien, in the form of a check payable to petitioner and the Michigan Department of Health and Human Services, P.O. Box 30435, Lansing MI 48909-7979; ATTN: ID # 0019315850. Petitioner agrees to endorse this payment to the State of Michigan for the Medicaid lien.**

This amount represents compensation for all damages that would be available under 42 U.S.C. § 300aa-15(a). Stipulation at ¶ 8.

The undersigned approves the requested amount for petitioner's compensation. Accordingly, an award should be made consistent with the stipulation.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the Clerk of Court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
