DECISION ON ATTORNEY'S FEES AND COSTS¹

On January 15, 2019, Petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that Ms. Strickland suffered Guillain-Barre Syndrome as a result of an influenza vaccine administered on October 13, 2017. (Petition at 1). On

October 29, 2020, a decision was issued awarding compensation to Petitioner based on the Respondent's proffer. (ECF No. 38).

Petitioner has now filed a motion for attorney's fees and costs, dated February 5, 2021 (ECF No. 43), requesting an award of \$27,056.08 (representing \$26,563.50 in fees and \$492.58 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that Petitioner has incurred out-of-pocket expenses in the amount of \$1,377.95. (ECF No. 43-4). Respondent did not file a response.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). **Accordingly, Petitioner is awarded the total amount of \$28,434.03³ as follows:**

- **A lump sum of \$27,056.08, representing reimbursement for attorneys' fees and costs, in the form of a check payable jointly to Petitioner and Turning Point Litigation; and**
- **A lump sum of \$1,377.95, representing reimbursement for Petitioner's costs, in the form of a check payable to Petitioner.**

In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.⁴

IT IS SO ORDERED.

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered.
