DECISION ON ATTORNEY'S FEES AND COSTS¹

On July 23, 2019, Andrew Janquitto filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury related to vaccine injury as a result of an influenza vaccine he received in his left shoulder on September 22, 2016. Petition at 1. On March 29, 2022, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. ECF No. 29.

Petitioner has now filed a motion for attorney's fees and costs, dated September 27, 2022 (ECF No. 32), requesting a total award of \$10,850.17 (representing \$9,456.00 in fees and \$1,394.17 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that he incurred no out-of-pocket expenses. ECF No. 32-3. Respondent reacted to the motion on October 11, 2022, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded at the Court's discretion. ECF No. 33. On October 14, 2022, Petitioner filed a reply requesting "the Court to exercise its discretion and determine a reasonable award for attorneys' fees and costs". ECF No. 34.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$10,850.17** (representing \$9,456.00 in fees and \$1,394.17 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
