### **DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On November 6, 2019, Todd L. Friberg filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleged the Table claim that he suffered a shoulder injury related to vaccine administration ("SIRVA") after receiving the influenza vaccine on October 18, 2018. Petition at 1, ¶¶ 2, 20. On July 6, 2022, a decision was issued awarding compensation to Petitioner in the amount of \$125,102.92. ECF No. 53.

Petitioner has now filed a motion for attorney's fees and costs, dated August 26, 2022 (ECF No. 58), requesting an award of \$71,679.76 in fees and costs incurred by Turning Point Litigation and \$8,078.57 in fees and costs incurred by counsel's former firm, Ward Black Law. *Id.* at 1.<sup>3</sup> In accordance with General Order No. 9, Petitioner filed a signed statement indicating that he incurred no out-of-pocket expenses. ECF No. 58-4. Respondent reacted to the motion on August 29, 2022, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded at the Court's discretion. ECF No. 59. On August 29, 2022, Petitioner filed a reply requesting the Chief Special Master "exercise his discretion and determine a reasonable award for attorney's fees and costs." ECF No. 60.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$79,758.33** (representing \$71,679.76 in fees and costs incurred by Turning Point Litigation and \$8,078.57 in fees and costs incurred by Ward Black Law.) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.<sup>4</sup>
