DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 31, 2019, Kimberly Draeger ("Petitioner") filed a petition for compensation pursuant to the National Vaccine Injury Compensation Program. 42 U.S.C. §§ 300aa-10 to -34 (2018)² (the "Vaccine Act" or "Program"). Petitioner alleged that the influenza ("flu") vaccine she received on September 14, 2017, caused her to suffer from acute disseminated encephalomyelitis ("ADEM"). Pet. at 3, ECF No. 1. On October 11, 2024, the parties filed a joint stipulation, which I adopted as my decision awarding compensation on October 15, 2024. ECF No. 52.

On April 1, 2025, Petitioner filed a motion for attorneys' fees and costs. Pet'r's Mot. for AFC, ECF No. 57. Petitioner requests total attorneys' fees and costs in the amount of \$77,031.69, representing \$17,469.00 in attorneys' fees and \$54.37 in attorneys' costs associated with representation by Urban & Taylor, S.C., as well as \$46,175.50 in attorneys' fees and \$13,332.82

in costs associated with representation by Attorney Jerome A. Konkel. Pet'r's Mot. for AFC at 8–9.. Pursuant to General Order No. 9, Petitioner represents that she did not personally incur any costs related to the prosecution of her petition. Pet'r's Mot. for AFC, Ex. E-E. Respondent responded to the motion on May 12, 2025, stating that Respondent “is satisfied that the statutory requirements for an award of attorneys’ fees and costs are met in this case” and asking the Court to “exercise its discretion and determine a reasonable award for attorneys’ fees and costs.” Resp’t’s Resp. at 2, 4, ECF No. 58. Petitioner did not file a reply. This matter is now ripe for consideration.

I. Reasonable Attorneys’ Fees and Costs

The Vaccine Act permits an award of “reasonable attorneys’ fees” and “other costs.” § 15(e)(1). If a petitioner succeeds on the merits of her or her claim, the award of attorneys’ fees is automatic. *Id.*; see *Sebelius v. Cloer*, 133 S. Ct. 1886, 1891 (2013). However, a petitioner need not prevail on entitlement to receive a fee award as long as the petition was brought in “good faith” and there was a “reasonable basis” for the claim to proceed. § 15(e)(1). Here, because Petitioner was awarded compensation pursuant to a stipulation, she is entitled to a final award of reasonable attorneys’ fees and costs.

The Federal Circuit has approved the lodestar approach to determine reasonable attorneys’ fees and costs under the Vaccine Act. *Avera v. Sec’y of Health & Human Servs.*, 515 F.3d 1343, 1348 (Fed. Cir. 2008). This is a two-step process. *Id.* First, a court determines an “initial estimate . . . by ‘multiplying the number of hours reasonably expended on the litigation times a reasonable hourly rate.’” *Id.* at 1347–48 (quoting *Blum v. Stenson*, 465 U.S. 886, 888 (1984)). Second, the court may make an upward or downward departure from the initial calculation of the fee award based on specific findings. *Id.* at 1348.

It is “well within the special master’s discretion” to determine the reasonableness of fees. *Saxton v. Sec’y of Health & Human Servs.*, 3 F.3d 1517, 1521–22 (Fed. Cir. 1993); see also *Hines v. Sec’y of Health & Human Servs.*, 22 Cl. Ct. 750, 753 (1991). (“[T]he reviewing court must grant the special master wide latitude in determining the reasonableness of both attorneys’ fees and costs.”). Applications for attorneys’ fees must include contemporaneous and specific billing records that indicate the work performed and the number of hours spent on said work. See *Savin v. Sec’y of Health & Human Servs.*, 85 Fed. Cl. 313, 316–18 (2008). Such applications, however, should not include hours that are “‘excessive, redundant, or otherwise unnecessary.’” *Saxton*, 3 F.3d at 1521 (quoting *Hensley v. Eckerhart*, 461 U.S. 424, 434 (1983)).

Reasonable hourly rates are determined by looking at the “prevailing market rate” in the relevant community. See *Blum*, 465 U.S. at 895. The “prevailing market rate” is akin to the rate “in the community for similar services by lawyers of reasonably comparable skill, experience and reputation.” *Id.* at 895, n.11. Petitioners bear the burden of providing adequate evidence to prove that the requested hourly rate is reasonable. *Id.*

A. Reasonable Hourly Rates

The decision in *McCulloch* provides a framework for consideration of appropriate ranges for attorneys' fees based upon the experience of the practicing attorney. *McCulloch v. Sec'y of Health & Human Servs.*, No. 09-293V, 2015 WL 5634323, at *19 (Fed. Cl. Spec. Mstr. Sept. 1, 2015), *motion for recons. denied*, 2015 WL 6181910 (Fed. Cl. Spec. Mstr. Sept. 21, 2015). The Court has since updated the *McCulloch* rates, and the Attorneys' Forum Hourly Rate Fee Schedules can be accessed online.³

1. Urban & Taylor, S.C.

Petitioner requests the following hourly rates for the work of her counsel, Attorney Scott B. Taylor: \$482.00 per hour for work performed in 2023, and \$538.00 per hour for work performed in 2024. These rates are consistent with what counsel has previously been awarded, and I find them to be reasonable herein.

2. Attorney Jerome A. Konkel

Petitioner requests the following hourly rates for the work of Attorney Jerome A. Konkel and his associates: for Mr. Konkel, \$368.00 per hour for work performed in 2018, \$378.00 per hour for work performed in 2019, \$433.00 per hour for work performed in 2020, \$455.00 per hour for work performed in 2021, \$490.00 per hour for work performed in 2022, \$525.00 per hour for work performed in 2023, and \$555.00 per hour for work performed in 2024; for Mr. Ryan Truesdale, \$325.00 per hour for work performed in 2021 and \$350.00 per hour for work performed in 2022; and, for Ms. Jubaile, \$289.00 per hour for work performed in 2023 and \$305.00 per hour for work performed in 2024. Petitioner also requests rates between \$112.00 per hour and \$182.00 per hour for work performed by paralegal Jennifer Varga from 2018-2025. These rates are consistent with what counsel and Ms. Varga have previously been awarded, and I find them to be reasonable herein.

B. Reasonable Number of Hours

Attorneys' fees are awarded for the "number of hours reasonably expended on the litigation." *Avera*, 515 F.3d at 1348. Counsel should not include in their fee requests hours that are "excessive, redundant, or otherwise unnecessary." *Saxton*, 3 F.3d at 1521 (quoting *Hensley v. Eckerhart*, 461 U.S. 424, 434 (1983)).

Upon review, I find the overall hours billed to be reasonable. Counsel have provided sufficiently detailed descriptions for the tasks performed, and upon review, I do not find any of the billing entries to be unreasonable. Accordingly, Petitioner is entitled to final attorneys' fees as follows: \$17,469.00 for the work performed by Urban & Taylor, S.C., and \$46,175.50 for the work performed by Attorney Konkel.

C. Costs

Like attorneys' fees, a request for reimbursement of attorneys' costs must be reasonable. *Perreira v. Sec'y of Health & Human Servs.*, 27 Fed. Cl. 29, 34 (Fed. Cl. 1992).

1. Urban & Taylor, S.C.

Petitioner requests a total of \$54.37 in attorneys' costs for postage. Pet'r's Mot. for AFC, Ex. C. Petitioner has provided adequate documentation supporting this cost and is therefore awarded the full amount sought.

2. Attorney Jerome A. Konkell

Petitioner requests a total of \$13,332.82 in attorneys' costs comprised of acquiring medical records, the Court's filing fee, medical records review and chronology services provided by Record Reform (\$1,295.00), and expert services provided by Derek Smith, M.D. Pet'r's Mot. for AFC, Exs. E-B, E-C, E-D. Petitioner requests reimbursement for expert services performed by Dr. Smith at \$500.00 per hour for 20.2 hours totaling \$10,100.00. Pet'r's Mot. for AFC, Ex. E-D. Dr. Smith's requested rate is reasonable and will therefore be awarded. Petitioner has provided adequate documentation supporting the remaining costs and is therefore awarded the full amount sought.

II. Conclusion

In accordance with the Vaccine Act, 42 U.S.C. §15(e) (2018), I have reviewed the billing records and costs in this case and find that Petitioner's request for fees and costs is reasonable. Based on the above analysis, I find that it is reasonable to compensate Petitioner and her counsel as follows:

Accordingly, I award following:

- 1) A lump sum in the amount of \$17,523.37, representing reimbursement for Petitioner's attorneys' fees and costs incurred by Urban & Taylor, S.C., to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.**
- 2) A lump sum in the amount of \$59,508.32, representing reimbursement for Petitioner's attorneys' fees and costs incurred by Attorney Jerome A. Konkell, to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.**

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.⁴
