DECISION ON ATTORNEY'S FEES AND COSTS¹

On December 31, 2019, Howard C. Wilinsky, M.D. filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury, specifically described as Parsonage Turner Syndrome (also known as brachial neuritis) caused-in-fact by the influenza vaccine he received on September 28, 2017. Petition at 1, ¶¶ 2, 17. On May 18, 2021, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. (ECF No. 26).

Petitioner has now filed a motion for attorney's fees and costs, dated June 2, 2021 (ECF No. 30), requesting a total award of \$6,998.95 (representing \$6,375.00 in fees and \$623.95 in costs). In accordance with General Order No. 9, counsel for Petitioner represents that Petitioner incurred no out-of-pocket expenses. (Id. at 2). Respondent reacted did not file a response.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$6,998.95** (representing \$6,375.00 in fees and \$623.95 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
