### **DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On March 12, 2020, Cynthia O'Donnell-Bove filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). On September 26, 2018, in her left shoulder, Petitioner received an influenza ("flu") vaccine, which vaccine is contained in the Vaccine Injury Table (the "Table"), 42 C.F.R. §100.3(a). Petitioner alleges that she suffered a left Shoulder Injury Related to Vaccine Administration within the time period set forth in the Table, and further alleges that she experienced the residual effects of her injury for more than six months.

Petition at 1. On August 15, 2022, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. ECF No. 56.

Petitioner has now filed a motion for attorney's fees and costs, dated October 6, 2022 (ECF No. 59), requesting a total award of \$57,591.55 (representing \$56,675.00 in fees and \$916.55 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that she incurred no out-of-pocket expenses. ECF No. 59-3. Respondent reacted to the motion on October 7, 2022, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded at the Court's discretion. ECF No. 60. Petitioner did not file a reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$57,591.55** (representing \$56,675.00 in fees and \$916.55 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. **Petitioner requests check be forwarded to mct law, 1605 Main Street, Suite 710, Sarasota, Florida 34236.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.<sup>3</sup>
