DECISION ON ATTORNEY'S FEES AND COSTS¹

On May 7, 2020, Kenneth Bryson filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that he suffered left arm injuries, including Parsonage Turner Syndrome, as a result of an influenza vaccine he received on October 30, 2018. (Petition at 1). On December 21, 2021, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. (ECF No. 41).

Petitioner has now filed a motion for attorney's fees and costs, dated January 6, 2022 (ECF No. 44), requesting a total award of \$24,459.97 (representing \$24,156.00 in fees and \$303.97 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that he incurred no out-of-pocket expenses. (ECF No. 50). Respondent reacted to the motion on January 18, 2022, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded at the Court's discretion. (ECF No. 45). On January 18, 2022, Petitioner filed a reply requesting the Court grant the requested amount of fees and costs in full. (ECF No. 46).³

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$24,459.97** (representing \$24,156.00 in fees and \$303.97 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.⁴

IT IS SO ORDERED.

³ Petitioner incorrectly lists the total of attorney fees and costs requested as \$24,985.07. (ECF No. 44 at 1, ECF No. 46). Billing records reflect that \$24,156.00 in attorney fees and \$303.97 in costs were incurred for a total requested award of \$24,459.97. (ECF No. 44-1 at 17-18).
