DECISION ON ATTORNEY'S FEES AND COSTS¹

On August 3, 2020, Tracy Sprinkle filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of an influenza vaccine she received to her right shoulder on September 29, 2019. Petition at 1. On August 15, 2024, I issued a decision awarding damages to Petitioner, following briefing by the parties. ECF No. 40.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$30,600.10 (representing \$30,017.20 for fees and \$582.90 for costs). Petitioner's

Application for Attorneys' Fees, filed Sept. 3, 2024, ECF No. 44. In accordance with General Order No. 9, counsel for Petitioner represents that Petitioner incurred no out-of-pocket expenses. *Id.* at 2.

Respondent reacted to the motion on Sept. 12, 2024, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, 3 n.2, ECF No. 45. Petitioner has not filed a reply.

The rates requested for work performed through the end of 2024 are reasonable and consistent with our prior determinations, and will therefore be adopted.

I also note this case required additional briefing regarding the issue of damages. See Petitioner's Brief in Support of Damages, filed Apr. 10, 2023, ECF No. 40; Petitioner's Reply to Respondent's Response to Brief in Support of Damages, May 15, 2023, ECF No. 37. Petitioner's counsel expended approximately 12.2 hours drafting the damages brief, and 5.7 hours drafting the reply brief. ECF No. 44 at 7-8. I find this time to have been reasonably incurred. (And all time billed to the matter was also reasonably incurred.)

Furthermore, Petitioner has provided supporting documentation for all claimed costs, ECF No. 44 at 13-20. And Respondent offered no specific objection to the rates or amounts sought. I have reviewed the requested costs and find them to be reasonable.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). **I award a total of \$30,600.10 (representing \$30,017.20 for fees and \$582.90 for costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel, Maximillian J. Muller.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.³

IT IS SO ORDERED.
