### **DECISION AWARDING DAMAGES**<sup>1</sup>

On August 26, 2020, Abbie Dover filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (SIRVA), caused by the administration of an influenza (flu) vaccination on October 24, 2018. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On December 29, 2021, a ruling on entitlement was issued, finding Petitioner entitled to compensation for SIRVA. On June 30, 2022, Respondent filed a proffer on award of compensation ("Proffer") indicating Petitioner should be awarded \$60,080.00 (comprised of \$55,000.00 for pain and suffering and \$5,080.00 for unreimbursed medical

expenses). Proffer at 1. In the Proffer, Respondent represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$60,080.00 (comprised of \$55,000.00 for pain and suffering and \$5,080.00 for unreimbursed medical expenses) in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.<sup>3</sup>

**RESPONDENT'S PROFFER ON AWARD OF COMPENSATION**

**I. Procedural History and Items of Compensation**

On December 7, 2021, respondent filed his Vaccine Rule 4(c) report, and conceded that entitlement to compensation was appropriate under the terms of the Vaccine Act. Thereafter, on December 29, 2021, the Chief Special Master issued a Ruling on Entitlement finding that petitioner was entitled to vaccine compensation for her left Shoulder Injury Related to Vaccine Administration ("SIRVA"). ECF Nos. 21, 24. Based on the evidence of record, respondent proffers that petitioner should be awarded \$60,080.00, which is comprised of damages for pain and suffering (\$55,000.00) and unreimbursable medical expenses (\$5,080.00). This amount represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a).<sup>1</sup> Petitioner agrees.

<sup>1</sup> Should petitioner die prior to entry of judgment, the parties reserve the right to move the Court for appropriate relief. In particular, respondent would oppose any award for future lost earnings and future pain and suffering.

**II. Form of the Award**

The parties recommend that compensation provided to petitioner should be made through a lump sum payment of \$60,080.00, in the form of a check payable to petitioner. Petitioner agrees.

Petitioner is a competent adult. Evidence of guardianship is not required in this case.
