### **DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On November 3, 2020, Todd Irish filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury related to vaccine administration (SIRVA) as a result of receiving an influenza (flu) vaccination on October 1, 2018. Petition at 1. On November 21, 2022, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. ECF No. 37.

Petitioner has now filed a motion for attorney's fees and costs, dated March 14, 2023 (ECF No. 42.), requesting an award of \$27,004.10 (representing \$26,261.90 in fees and \$742.20 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that he incurred out-of-pocket expenses in the amount of \$29.50. ECF No. 43. Respondent reacted to the motion on March 16, 2023, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded at the Court's discretion. ECF No. 44. Petitioner did not file a reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. **Accordingly, petitioner is awarded the total amount of \$27,033.60<sup>3</sup> as follows:**

- **A lump sum of \$27,004.10, representing reimbursement for attorneys' fees and costs, in the form of a check payable jointly to petitioner and petitioner's counsel, Ronald Craig Homer; and**
- **A lump sum of \$29.50, representing reimbursement for petitioner's costs, in the form of a check payable to Petitioner.**

In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this decision.<sup>4</sup>

This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered.
