DECISION ON ATTORNEY'S FEES AND COSTS¹

On December 2, 2020, Steven Rothenberg filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury related to vaccine administration ("SIRVA") caused by an influenza vaccine administered on October 7, 2019. Petition, ECF No. 1. On February 21, 2023, I issued a decision awarding compensation to Petitioner based on the Respondent's proffer. ECF No. 45.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$31,087.25 (representing \$30,062.50 in attorney's fees and \$1,024.75 in attorney's costs). Petitioner's Application for Attorney's Fees and Costs ("Motion") filed July 20, 2023, ECF No. 50. In accordance with General Order No. 9, Petitioner represents that Petitioner incurred \$9.25 in out-of-pocket expenses. ECF No. 51.

Respondent reacted to the motion on July 27, 2023, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, ECF No. 52. Petitioner did not file a reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates. Furthermore, Petitioner has provided supporting documentation for all claimed costs. Attachment to Motion at 28-49. Respondent offered no specific objection to the rates or amounts sought.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$31,096.50** (representing **\$30,062.50** in fees; **\$1,024.75** in costs; and **\$9.25** in out-of-pocket expenses) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel, Ronald C. Homer. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.³
