DECISION ON ATTORNEY'S FEES AND COSTS¹

On December 2, 2020, Brenda Lindsey filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that she suffered a left shoulder injury related to vaccine administration resulting from an influenza vaccine received on December 29, 2018. Petition, ECF No. 1. On December 2, 2022, I issued a decision awarding compensation to Petitioner based on the Respondent's proffer. ECF No. 52.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$63,760.60 (representing \$60,319.80 for attorney's fees, \$3,440.80 for attorney's costs). Petitioner's Application for Attorney's Fees and Costs ("Motion"), filed Apr. 20,

2023, ECF No. 58. In accordance with General Order No. 9, Petitioner filed a signed statement indicating that Petitioner incurred no out-of-pocket expenses. ECF No. 58-1.

Respondent reacted to the motion on Apr. 24, 2023, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, 3 n.2, ECF No. 60. Petitioner filed a reply on Apr. 25, 2023, requesting that the Court award all fees and costs as indicated in petitioner's motion. ECF No. 61.

The rates requested for work performed through the end of 2021 are reasonable and consistent with our prior determinations, and will therefore be adopted. Petitioner has also requested hourly rates for her attorney Ramon Rodriguez, III, as follows: the hourly rate of \$458 per hour for work performed in 2022 – representing a rate increase of \$14; and \$482 per hour for work performed in 2023 - representing a rate increase of \$24. Petitioner also requests the hourly rate of \$186 per hour for paralegal work performed in 2023. Motion at 4-5. I find these hourly rates to be reasonable, and will award the attorney's fees requested. (And all time billed to the matter was also reasonably incurred).

Furthermore, Petitioner has provided supporting documentation for all claimed costs. Attachment to Motion at 18-89. And Respondent offered no specific objection to the rates or amounts sought.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$63,760.60 (representing \$60,319.80 for attorney's fees, \$3,440.80 for attorney's costs) in the form of a check jointly payable to Petitioner and Petitioner's counsel, Ramon Rodriguez, III.**

In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.³
