RULING ON ENTITLEMENT¹

On December 8, 2020, Elaine Tornatore filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (“SIRVA”) following her receipt of an influenza vaccine on August 17, 2020. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On June 9, 2023, Respondent filed his Rule 4(c) report in which he **concedes** that Petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, Respondent agrees that Petitioner has satisfied the criteria set forth in the Table and the QAI for SIRVA. *Id.* at 6 (citing 42 C.F.R. §§ 100.3(a)(XIV)(B), 100.3(c)(10).

Respondent further agrees that Petitioner has satisfied the other statutory and jurisdictional issues required for eligibility under the Vaccine Program. *Id.*

In view of Respondent's position and the evidence of record, I find that Petitioner is entitled to compensation.
