DECISION AWARDING DAMAGES¹

On December 30, 2020, Sabrina Eve Valentine filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleges that she suffered a Shoulder Injury Related to Vaccine Administration (“SIRVA”) as a result of a tetanus, diphtheria, and acellular pertussis (“Tdap”) vaccine administered to her on February 6, 2020. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On December 19, 2022, a ruling on entitlement was issued finding Petitioner entitled to compensation for SIRVA. On March 28, 2023, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded a total of \$65,000.00 for her actual pain and suffering. Proffer at 1-2. In the Proffer, Respondent

represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$65,000.00 (for actual pain and suffering) in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.³

RESPONDENT’S PROFFER ON AWARD OF COMPENSATION

On December 30, 2020, Sabrina Eve Valentine (“petitioner”) filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, as amended (“the Vaccine Act” or “the Act”), 42 U.S.C. §§ 300aa-1 to -34. Petitioner alleges that she suffered a Shoulder Injury Related to Vaccine Administration (“SIRVA”), as a result of tetanus, diphtheria, and acellular-pertussis (“Tdap”) vaccine administered to her on February 6, 2020. Petition at 2. On December 16, 2022, the Secretary of Health and Human Services (“respondent”) filed a Rule 4(c) Report recommending that compensation be awarded. ECF No. 30. On December 19, 2022, the Chief Special Master issued a Ruling on Entitlement finding petitioner entitled to compensation. ECF No. 31.

I. Items of Compensation

Respondent proffers that petitioner should be awarded \$65,000.00 in actual pain and suffering. *See* 42 U.S.C. § 300aa-15(a)(4). Petitioner agrees.

II. Form of the Award

Petitioner is a competent adult. Evidence of guardianship is not required in this case. Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment as described below and requests that the Chief Special Master's decision and the Court's judgment award the following¹: a lump sum payment of \$65,000.00, representing compensation for all elements of economic and noneconomic damages, in the form of a check payable to petitioner, Sabrina Eve Valentine.

III. Summary of Recommended Payments Following Judgment

Lump sum payable to petitioner, Sabrina Eve Valentine: \$65,000.00
