## **ORDER CONCLUDING PROCEEDINGS**<sup>1</sup>

On January 7, 2021, Julia Shatlock filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. § 300aa—10 through 34.<sup>2</sup> Petitioner alleged that she suffered an adverse reaction to an influenza vaccination that she received on October 3, 2019. Petition at 1. On April 27, 2021, Petitioner filed a joint stipulation to voluntarily dismiss this case.

In light of Petitioner's "stipulation of dismissal signed by all parties who have appeared in the action" pursuant to Vaccine Rule 21(a)(1)(B), **this case is dismissed without prejudice.**
