DECISION ON ATTORNEY'S FEES AND COSTS¹

On January 7, 2021, Kathryn Rikard filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner filed an amended petition on May 5, 2022. ECF No. 21. Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA"), a defined Table injury, or in the alternative a caused-in-fact injury, after

receiving the influenza (“flu”) vaccine on September 25, 2019. Amended Petition at 1, ¶¶ 1, 9. On August 1, 2023, I issued a decision awarding compensation to Petitioner based on the parties’ stipulation. ECF No. 34.

Petitioner has now filed a motion for attorney’s fees and costs, requesting an award of \$26,807.38 (representing \$24,353.00 in fees plus \$2,454.38 in costs). Petitioner’s Application for Attorneys’ Fees (“Motion”) filed January 21, 2024, ECF No. 39. In accordance with General Order No. 9, Petitioner filed a signed statement indicating that she incurred no out-of-pocket expenses. Id. at 2. Respondent did not respond to Petitioner’s Motion.

I have reviewed the billing records submitted with Petitioner’s request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates. Furthermore, Petitioner has provided supporting documentation for all claimed costs. Motion Ex. 2 at 1 - 9. Respondent offered no specific objection to the rates or amounts sought.

The Vaccine Act permits an award of reasonable attorney’s fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner’s Motion for attorney’s fees and costs. **I award a total of \$26,807.38 (representing \$24,353.00 in fees plus \$2,454.38 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner’s counsel, Leah VaSahnja Durant.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
