**DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On January 12, 2021, Deidre Bratton filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury related to vaccine administration after receiving an influenza vaccination on September 11, 2020. Petition, ECF No. 1. On January 30, 2025, I issued a decision awarding compensation to Petitioner based on the parties' stipulation. ECF No. 51.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$30,908.48 (representing \$29,249.00 in fees plus \$1,659.48 in costs). Application for Fees and Costs ("Motion") filed January 31, 2025, ECF No. 55. Furthermore, Petitioner's counsel represents that Petitioner has not incurred personal out-of-pocket expenses. *Id.* at 2.

Respondent reacted to the motion on February 7, 2025, reporting that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-4, ECF No. 56. Petitioner filed no reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. The rates requested for work performed through the end of 2024 are reasonable and consistent with our prior determinations and will therefore be adopted. Petitioner has also requested the hourly rate of \$450 for 2025 work performed by attorney Jonathan Svitak, representing a rate increase of \$40 from the previous year. I find the proposed rate to be reasonable and award it herein. And all time billed to the matter was also reasonably incurred.

Furthermore, Petitioner has provided supporting documentation for all claimed costs. ECF No. 55-4. Respondent offered no specific objection to the rates or amounts sought. I find the requested costs reasonable and hereby award them in full.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$30,908.48 (representing \$29,249.00 in fees plus \$1,659.48 in costs) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.<sup>3</sup>
