DECISION AWARDING DAMAGES¹

January 12, 2021, Heather Hogan filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). she suffered a Table injury – Shoulder Injury Related to Vaccine Administration (“SIRVA”) – as a result of her October 22, 2019 influenza (“flu”) vaccine. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On June 30, 2022, a ruling on entitlement was issued, finding Petitioner entitled to compensation for SIRVA. On September 8, 2022, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded \$75,000.00 for pain and suffering, and unreimbursable expenses in the amount of \$2,677.33. Proffer at 1-2. In the Proffer, Respondent represented that Petitioner agrees with the proffered award. *Id.*

Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$77,677.33 (representing \$75,000.00 for pain and suffering and unreimbursable expenses of \$2,677.33) in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.³

IT IS SO ORDERED.

These amounts represent all elements of compensation to which petitioner is entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

II. Form of the Award

Respondent recommends that the compensation provided to petitioner should be made as described below, and requests that the Chief Special Master's damages decision and the Court's judgment award the following:¹

- A. A lump sum of **\$77,677.33**, in the form of a check payable to petitioner. This amount represents compensation for all damages that would be available under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

Petitioner is a competent adult. Evidence of guardianship is not required in this case.
