DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On April 15, 2021, Mikhail Roubakha (“Petitioner”) filed a petition in the National Vaccine Injury Program² alleging that he suffered a Table injury of Guillain-Barré Syndrome (“GBS”) as a result of an influenza (“flu”) vaccine he received on September 21, 2018. Petition at Preamble (ECF No. 1). The undersigned issued a decision based on stipulation on September 16, 2024. Decision dated Sept. 16, 2024 (ECF No. 70).

All citations in this Decision to individual sections of the Vaccine Act are to 42 U.S.C.A. § 300aa.

On February 19, 2025, Petitioner filed an application for attorneys' fees and costs. Petitioner's Motion for Attorneys' Fees and Costs ("Pet. Mot."), filed Feb. 19, 2025 (ECF No. 75). Petitioner requests compensation in the amount of \$60,641.87, representing \$38,707.20 in attorneys' fees and \$21,934.67 in costs. Id. at 1. Petitioner warrants that he has not personally incurred any costs in pursuit of her claim for compensation. Id. Respondent filed his response on February 21, 2025, stating he "is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case." Respondent's Response to Pet. Mot., filed Feb. 21, 2025, at 2 (ECF No. 76). Petitioner did not file a reply thereafter. The matter is now ripe for disposition.

Petitioner requests the following hourly rates for the work of his counsel: for Mr. Edward Kraus, \$418.00 per hour for work performed in 2019, \$435.00 per hour for work performed in 2020, \$458.00 per hour for work performed in 2021, \$472.00 per hour for work performed in 2022, \$497.00 per hour for work performed in 2023, and \$525.00 per hour for work performed in 2024; and for Ms. Amy Kraus, \$365.00 per hour for work performed in 2020, \$384.00 per hour for work performed in 2021, \$414.00 per hour for work performed in 2022, \$436.00 per hour for work performed in 2023, \$460.00 per hour for work performed in 2024, and \$494.00 per hour for work performed in 2025. Petitioner also requests rates between \$145.00 and \$186.00 for work of their counsel's paralegals performed from 2019 to 2025.

The undersigned finds the rates are consistent with what counsel have previously been awarded for their Vaccine Program work, and finds them to be reasonable herein. The undersigned has also reviewed the submitted billing entries and finds the total number of hours billed to be reasonable and will award them in full.

Lastly, the undersigned has reviewed the requested costs and finds them to be reasonable and supported with appropriate documentation. Accordingly, the full amount of costs shall be awarded.

Therefore, the undersigned finds no cause to reduce the requested hours or rates, or the requested costs.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of Petitioner's request, the undersigned **GRANTS** Petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards:

Petitioner is awarded attorneys' fees and costs in the total amount of \$60,641.87, to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the Clerk of Court **SHALL ENTER JUDGMENT** in accordance with this Decision.³
