DECISION AWARDING DAMAGES¹

On July 20, 2020, Kathleen Pachucki filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (“SIRVA”) as a result of an influenza (“flu”) vaccine that was administered on January 7, 2020. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 21, 2023, a ruling on entitlement was issued, finding Petitioner entitled to compensation for SIRVA. On May 2, 2023, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded \$120,000.00 in pain and suffering. Proffer at 1. In the Proffer, Respondent represented that Petitioner agrees with

the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$120,000.00 (in pain and suffering) in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.³

RESPONDENT’S PROFFER ON AWARD OF COMPENSATION

On July 20, 2021, Kathleen Pachucki (“petitioner”) filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34 (“Vaccine Act” or “Act”), alleging that she suffered a shoulder injury related to vaccine administration (“SIRVA”) caused by her receipt of an influenza vaccination on January 7, 2020. Petition at 1. On April 19, 2023, the Secretary of Health and Human Services (“respondent”) filed his Rule 4(c) report recommending that this case is appropriate for compensation under the terms of the Act for a SIRVA Table injury, and April 21, 2023, the Chief Special Master issued a Ruling on Entitlement finding petitioner entitled to compensation. ECF No. 36; ECF No. 37.

I. Item of Compensation

Respondent proffers that petitioner should be awarded \$ 120,000.00 in pain and suffering. *See* 42 U.S.C. § 300aa-15(a)(4). Petitioner agrees.

This amount represents all elements of compensation to which petitioner is entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

II. Form of the Award

Petitioner is a competent adult. Evidence of guardianship is not required in this case. Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment and requests that the Chief Special Master's decision and the Court's judgment award the following¹: a lump sum payment of \$ 120,000.00, representing economic and noneconomic damages, in the form of a check payable to petitioner, Kathleen Pachucki.

III. Summary of Recommended Payment Following Judgment

Lump sum award payable to petitioner, Kathleen Pachucki: \$ 120,000.00.
