**DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On January 10, 2022, Jacqueline Nyarko filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered a Table shoulder injury related to vaccine administration or in the alternative, that her alleged shoulder injury was a result of an influenza vaccine administered on November 7, 2020. Petition, ECF No. 1. On January 30, 2024, I issued a decision awarding compensation to Petitioner based on the parties' stipulation. ECF No. 47.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$40,219.11 (representing \$38,405.30 in fees plus \$1,813.81 in costs). Application for Fees and Costs ("Motion") filed March 20, 2024, ECF No. 52. Furthermore, counsel for Petitioner represents that Petitioner incurred no personal out-of-pocket expenses. *Id.* at 2.

Respondent reacted to the motion on Mar. 22, 2024, reporting that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to my discretion. Respondent's Response to Motion at 2-3, ECF No. 53. Petitioner filed a reply reiterating that all fees and costs incurred are reasonable. ECF No. 54.

The rates requested for work performed through the end of 2023 are reasonable and consistent with our prior determinations, and will therefore be adopted. Petitioner has also requested the hourly rate of \$478 for 2024 work performed by attorney William E. Cochran, representing a rate increase of \$28; and the rate of \$183 for paralegal work performed in 2024. I find these rates to be reasonable and will award the attorney's fees requested. Furthermore, all time billed to the matter was reasonably incurred and Petitioner has provided supporting documentation for all claimed costs. ECF No. 52-2.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$40,219.11 (representing \$38,405.30 in fees plus \$1,813.81 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel, William E. Cochran, Jr.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.<sup>3</sup>
